Subject: Report #2018-03 of Apparent Violation of the Ventura County Campaign Finance Reform Ordinance (No. 4510)

In accordance with Section 1305(e) of the Ventura County Campaign Finance Reform Ordinance (No. 4510), the Ventura County Clerk-Recorder, Registrar of Voters is hereby reporting to the County Executive Office apparent violations of Sections 1266, 1267(a), and 1271(a) of Ordinance #4510, by the Committee *Waters for Supervisor 2018*.

Schedule A of the attached PDF of California Form 460 (January 1, 2018 - April 21, 2018, filed April 25, 2018), lists the following contributions to the Committee *Waters for Supervisor 2018*, designated as either Primary Election contributions (P2018) or General Election contributions (G2018):

April 11, 2018 – Jurgen Gramckow - \$375 (P2018) and \$375 (G2018)

April 2, 2018 – Lynn Gray - \$375 (P2018) and \$375 (G2018)

April 2, 2018 – Donald Jensen - \$375 (P2018) and \$375 (G2018)

April 7, 2018 – Rancho Temescal, LLC - \$375 (P2018) and \$375 (G2018)

Section 1266 states:

“Each county candidate shall file with the Clerk a statement of acceptance or rejection of the voluntary expenditure limits set forth in Section 1265 before accepting any contributions.”

Mr. Waters has not filed a Voluntary Expenditure Limitation Statement for the 2018 General Election. Therefore, if the above listed contributions, designated as G2018, are in fact General Election contributions, this would appear to be a violation of Section 1266.

However, Section 1272(a) states:

“For purposes of the limits of this ordinance and reporting procedures, if there is a general (runoff) election, contributions or expenditures made at any time from the beginning date a candidate may commence receiving contributions pursuant to Section 1280 to the day before the primary election shall be considered primary election contributions. For the general (runoff) election, contributions made from the date of the primary election through 90 days after the general (runoff) election shall be considered general (runoff) election contributions.”

And Section 1267(a) states:

“Except as provided in Section 1268, no person shall make to any county candidate, or the controlled committee of such a candidate or elective county officer, and no such county candidate, or controlled committee of such candidate shall accept from a person any

contribution totaling more than three hundred and seventy five dollars (\$375) for each of the following elections for which the individual is a candidate: a primary election or a general (runoff) election.”

Mr. Waters did not accept the Voluntary Expenditure Limit for the 2018 Primary Election (see attached Voluntary Expenditure Limitation Statement). Therefore, if the above listed contributions, designated as G2018, are determined to be Primary Election contributions per Section 1272(a), then this would appear to be a violation of Section 1267(a), as the four contributors listed above would have exceeded the contribution limit of \$375 for a non-participating candidate.

Schedules E and F of the attached Form 460 show expenditures totaling \$49,266.32. Section 1271(a) states:

“If a non-participating candidate's total expenditures are twenty percent (20%) or more of the expenditure limits, the candidate shall notify and declare to the Clerk and opposing candidates within twenty-four (24) hours of the time such a total is reached.”

To date, our office has not received any such notification, apart from the filing of the attached Form 460. Because the committee's expenditures have exceeded \$42,000 (20% of the Voluntary Expenditure Limit), this appears to be a violation of Section 1271(a).

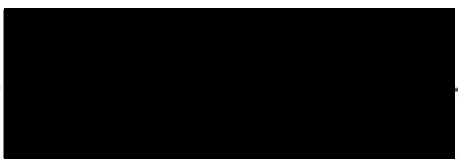
