If you do not follow these instructions it may cause your ballot not to be counted.

We have determined that the signature you provided on your Vote By Mail Ballot does not match the signature(s) on file in your voter record. In order to ensure that your Vote By Mail Ballot will be counted, the Signature Verification Statement must be completed and returned by the date listed below.

Choose one of the following ways to return your Signature Verification Statement:

- **Come to the Elections Division in person** to submit or complete a Signature Verification Statement, Monday through Friday, 8:00 a.m. to 5:00 p.m., until November 26, 2018.
- **Drop off at a Ventura County polling place** your completed Signature Verification Statement by 8 p.m. on Election Day, November 6, 2018.
- **Drop in the 24-hour Ballot Drop-off Box** your completed Signature Verification Statement no later than 5 p.m. on November 26, 2018. Two 24-hour Ballot Drop-off Boxes (one walk-up and one drive-up) are located at the entrance to the Ventura County Government Center, Hall of Administration Building, 800 South Victoria Avenue, Ventura.
- **Mail** your completed Signature Verification Statement in an envelope addressed to: Elections Division, OFFICIAL BALLOT INFORMATION, 800 South Victoria Avenue, Ventura, CA 93009-1200. Your completed statement must be received by 5 p.m. on November 26, 2018. **Postmarks will not be accepted.**
- **Email** your completed Signature Verification Statement to VoteByMail@ventura.org. The statement must be received by 5 p.m. November 26, 2018.
- **Fax** your completed Signature Verification Statement to (805) 648-9200. The statement must be received by 5 p.m. on November 26, 2018.
