Notice - You Did Not Sign Your Vote By Mail Ballot Return Envelope

Read instructions carefully before completing and signing the statement. If you do not follow these instructions it may cause your ballot not to be counted.

Choose one of the following ways to return your Unsigned Ballot Envelope Statement:

- **Come to the Elections Division in person** to sign your Vote By Mail Ballot envelope image, or complete an Unsigned Ballot Envelope Statement, Monday through Friday, 8 a.m. to 5 p.m., until November 14, 2018.
- **Drop off at a Ventura County polling place**, your completed Unsigned Ballot Envelope Statement by 8 p.m. on Election Day, November 6, 2018.
- **Drop in the 24-hour Ballot Drop-off Box** your completed Unsigned Ballot Envelope Statement no later than 5 p.m. on November 14, 2018. Two 24-hour Ballot Drop-off Boxes (one walk-up and one drive-up) are located at the entrance to the Ventura County Government Center, Hall of Administration Building, 800 South Victoria Avenue, Ventura.
- **Mail** your completed Unsigned Ballot Envelope Statement in an envelope addressed to: Elections Division, OFFICIAL BALLOT INFORMATION, 800 South Victoria Avenue, Ventura, CA 93009-1200. Your completed statement must be received by 5 p.m. on November 14, 2018. **Postmarks will not be accepted.**
- **Email** your completed Unsigned Ballot Envelope Statement to VoteByMail@ventura.org. The statement must be received by 5 p.m. on November 14, 2018.
- **Fax** your completed Unsigned Ballot Envelope Statement to (805) 648-9200. The statement must be received by 5 p.m. on November 14, 2018.
