Subject: **Addendum #1 to Report #2018-01 of Apparent Violation of the Ventura County Campaign Finance Reform Ordinance (No. 4510)**

In accordance with Section 1305(e) of the Ventura County Campaign Finance Reform Ordinance (No. 4510), the Ventura County Clerk-Recorder, Registrar of Voters is hereby reporting to the County Executive Office the following Addendum #1 to the February 2, 2018 Report #2018-01 of apparent violation of Section 1268(a) of Ordinance #4510, by the Committee *Vote for Parks for Supervisor 2018*.

The attached Amended Form 460 was filed by the Committee *Vote for Parks for Supervisor 2018* on February 2, 2018, subsequent to Report #2018-01. The Amended Form 460 indicates that the October 16, 2017 contribution from Peggy Ludington was an erroneous listing. The Amended Form 460 shows only one contribution from Peggy Ludington, received on October 30, 2017.

Based on the review of the Amended Form 460, the Ventura County Clerk-Recorder, Registrar of Voters has determined that the contributions from Peggy Ludington now total \$750, as listed on these documents, and no longer exceed on their face the \$750 individual contribution limit over the course of an election cycle, and, therefore, no longer appear to be a violation of Section 1268(a) of the Ordinance.
