**INSTRUCTIONS TO FAX YOUR VOTED BALLOT**

Per California Elections Code 3106(a), a military or overseas voter who is living outside of the territorial limits of the United States or the District of Columbia, or is called for military service within the United States on or after the final date to make application for a Vote By Mail ballot, may return his or her ballot by facsimile transmission.

**To be counted, the ballot returned by Fax must meet the following criteria:**

- The Oath of Voter must be completed and signed by the voter.
- The Oath of Voter must be accompanied by the Identification Return Envelope containing all of the information required.
- The Oath of Voter and Identification Return Envelope must be received by the Elections Office no later than 8:00 p.m. Pacific Time on Election Day.

**OATH OF VOTER**
