November 3, 2020 Presidential General Election

Notice - You Did Not Sign Your Vote By Mail Ballot Return Envelope or Provisional Ballot

Read the instructions carefully before completing and signing the statement. If you do not follow these instructions it may cause your ballot not to be counted.

Choose one of the following ways to return your Unsigned Ballot Envelope Statement:

- **Drop off at an In-Person Voting Location** throughout the county starting October 31 through November 3, 2020. For more information on the In-Person Voting Locations go to <https://recorder.countyofventura.org/november-3-2020-presidential-general-election-in-person-voting-locations/>.
- **Drop in a Ballot Drop-off Box** your completed Unsigned Ballot Envelope Statement. Locations of the Ballot Drop-off Boxes are on our website at <https://recorder.countyofventura.org/november-3-2020-presidential-general-election/>. The statement must be dropped off by November 25, 2020.
- **Mail** your completed Unsigned Ballot Envelope Statement in an envelope addressed to: Elections Division, OFFICIAL BALLOT INFORMATION, 800 South Victoria Avenue, Ventura, CA 93009-1200. Completed statement must be received by November 25, 2020. **Postmarks will not count.**
- **Email** your completed Unsigned Ballot Envelope Statement to VenturaVoterRegistration@ventura.org. It must be received by November 25, 2020.
- **Fax** your completed Unsigned Ballot Envelope Statement to (805) 648-9200. It must be received by November 25, 2020.

Please note that the signature provided on the completed Statement may be added to your registration record to be used for signature comparison purposes in future elections.

I declare under penalty of perjury that I requested and returned a Vote By Mail or provisional ballot and that I have not and will not vote more than one ballot in this election. I am a resident of the precinct in which I have voted, and I am the person whose name appears on the Vote By Mail or provisional ballot envelope. I understand that if I commit or attempt any fraud in connection with voting, or if I aid or abet fraud or attempt to aid or abet fraud in connection with voting, I may be convicted of a felony punishable by imprisonment for 16 months or two or three years.

I understand that my failure to sign this Statement means that my Vote By Mail or provisional ballot will be invalidated.
