**September 14, 2021 California Gubernatorial Recall Election**

**Notice - You Did Not Sign Your Vote By Mail Ballot Return Envelope or Provisional Ballot**

Read the instructions carefully before completing and signing the statement. If you do not follow these instructions it may cause your ballot not to be counted.

**Choose one of the following ways to return your completed Unsigned Ballot Envelope Statement:**

- **Drop in a Ballot Drop-off Box** throughout the county starting August 16 through September 14, 2021. The statement must be dropped off by 8:00 p.m. on September 14, 2021. Starting September 15, 2021 through October 1, 2021 you may drop the statement in a Ballot Drop-off Box located at the Government Center Hall of Administration or Government Center Hall of Justice. - **Mail** in an envelope addressed to: Elections Division, OFFICIAL BALLOT INFORMATION, 800 South Victoria Avenue, Ventura, CA 93009-1200. Completed statements must be received by October 1, 2021.  
**Postmarks will not count.**
- **Email** to [VenturaVoterRegistration@ventura.org](mailto:VenturaVoterRegistration@ventura.org). The statement must be received by October 1, 2021.
- **Fax** to (805) 648-9200. The statement must be received by October 1, 2021.
- **Drop off at an In-Person Voting Location** throughout the county starting September 11 through September 14, 2021. The statement must be dropped off by 8:00 p.m. on September 14, 2021. Please note that the signature provided on the completed Statement may be added to your registration record to be used for signature comparison purposes in future elections.

I understand that if I commit or attempt any fraud in connection with voting, or if I aid or abet fraud or attempt to aid or abet fraud in connection with voting, I may be convicted of a felony punishable by imprisonment for 16 months or two or three years.
