In addition to any applicable recording fees, a fee of \$75.00 will be charged at the time of recording any real estate instrument, paper or notice except those expressly exempted from payment of recording fees. The fee shall not exceed \$225.00 per transaction (defined as instruments, papers, or notices presented concurrently and related to the same parties and property).		
A limited number of statutory exemptions to this fee apply:		
<ul style="list-style-type: none"> <li>• Exempt from fee per GC 27388.1 (a)(2); recorded concurrently "in connection with " a transfer subject to the imposition of documentary transfer tax", <b>or</b></li> <li>• Exempt from fee per GC 27388.1 (a)(2); recorded concurrently "in connection with " a transfer of real property that is residential dwelling to an owner-occupier", <b>or</b></li> <li>• Exempt from fee per GC 27388.1 (a)(1); "fee cap of \$225 reached" <b>or</b></li> <li>• Exempt from fee per GC 27388.1 (a)(1) (1) Not related to real property</li> </ul>		
When an exemption is applicable, a valid declaration of exemption must be shown on the face of the document or on a cover page which will be affixed to and will become part of the document. If no valid exemption is declared, the fee will be applied. There is no provision for processing refund requests for exemptions claimed after recording.
